- If you cancel your rental for any reason, you will only be refunded 50% of your total rental fee. If you wish to reschedule your rental for another time within the same season, you may do so at no additional charge and no loss of past payment. If weather does not allow us to open for your party, we will try to reschedule or you will receive a 100% refund.
- For picnic table rentals: In addition to the picnic table rental fee, all persons entering the facility are required to pay the appropriate admission fee.
- The fees for the Ultimate Rental and Splash Bash Rental include a \$25 refundable cleaning deposit. The \$25 cleaning deposit refund will be processed the week following the party if you clean up your area and the manager approves.

### **Spray 'N Play Rules**

- 1. No person suffering from any contagious disease or infectious condition shall be allowed to enter the facility.
